**Notification on Major Holdings pursuant to Section 29 of the Danish Securities Trading Act and Executive Order no. 728 of 11 July 2005**

Dear Sir/Madam:

Pursuant to the Danish Securities Trading Act and the Executive Order on Assessment, Notification and Disclosure of Major Holdings in Companies with Shares Listed on a Stock Exchange or Traded in an Authorized Market Place (Executive Order no. 728 of 11 July 2005), this serves as notice of substantial shareholder disclosure for Massachusetts Financial Services Company and its investment advisory subsidiaries ("MFS"), which serve as investment manager for its various mutual funds, institutional account and other advisory clients.

MFS and its various subsidiaries have acquired 293,000 shares in TopoTarget A/S on 16 March 2007. As of end of day, 16 March 2007, MFS, on behalf of its various clients<sup>1</sup>, held 2,389,293 shares, equivalent to 5.23% of the total issued share capital of TopoTarget A/S (based on 45,684,880 total shares outstanding). Please note that of 5.23% of total shares held by MFS, 2.43% represents shares where MFS has discretionary voting power. Various subsidiary investment advisers of MFS manage the shareholdings, which are set forth below:
