Dear Sir/Madam.

I am writing to inform you that in light of the European Union Transparency Directive (EUTD) implemented on Monday 22 January 2007, we have reviewed and amended our major shareholder disclosure process. The attached disclosure is we believe in line with the requirements of that Directive.

This report is being filed by Fidelity International Limited ("FIL"), a Bermuda Corporation whose principal address is located at Pembroke Hall, 42 Crow Lane, Hamilton, Bermuda, and its direct and indirect subsidiaries. FIL is making this notification on behalf of itself and various "mutual funds" and other investment accounts managed by FIL.

A previous report was submitted dated 20 December 2006, declaring the "mutual funds" and other investment accounts managed by affiliates of FIL and FMR Corp as crossing below the 10% threshold.

This report is to inform of revised holdings of FIL following the disaggregation between FIL and FMR Corp as of close of business 19 January 2007.

The company's capital consists of 185,204,103 shares. As a consequence, as of 19 January 2007, the number of shares held or deemed to be held by FIL is 3,222,379 which represents approximately 1.74% percent of the company's shares in issue.

FIL's holdings are made for investment purposes and not with the intent to influence the control or direction of Vestas Wind Systems AS.

Enclosed herewith please find the information required by the 1995 Securities Trading Act, Section 29 and Executive Order No.328 of April 22, 1996 of The Board of Business and Companies.

1. The person making this notification is:

Fidelity International Limited, a Bermuda Corporation whose principal business address is P. O. Box HM 670, Hamilton HMCX, Bermuda.

FIL is making this notification on behalf of the "mutual funds" and management companies whose names are attached hereto.

- The corporate name of the company whose shares are held is Vestas Wind Systems AS. The company's capital consists of 185,204,103 shares.
- 4. The 5% threshold was crossed by means of the disaggregation of FMR Corp. and FIL. As a consequence, the number of shares held or deemed to be held by the shareholder is:

3,222,379 shares, that is, 1.74% of the total shares.

- 5. Attached hereto please find (i) the corporate name and principal business office of each person who belongs to the group and who holds directly shares, and (ii) the number and percentage of shares held directly by each such person.
- 6. FMR Corp., FMTC, and FIL are parent companies that have certain common shareholders and whose subsidiaries are management companies who give advice to "mutual funds" with respect to their investment and their portfolios. FMR Corp. and FIL are separate and independent corporate entities. FMR Corp. and FIL are managed independently and their board of Directors are generally composed of different individuals. Their investment decisions are made independently.

The "mutual funds" are the actual shareholders of the shares discussed herein, each "mutual fund" holds the number of shares indicated on the attached diagram. However, by reason of management agreements between the investment managers and the directors or trustees of the "mutual funds", the management companies have been given the power to make decisions with respect to the shares of the company named in paragraph 3 above, including in certain cases, decisions with respect to voting rights.

Each management company makes independent decisions with respect to the shares, including voting rights and purchase or sale of the shares. The management companies make their decisions solely for reasons of investment on behalf of and in the name of the "mutual funds," and they have no intention of controlling the business or the management of the company in question. In addition, each "mutual fund" or portfolio having a separate investment policy, the investment decisions are made separately for each particular "mutual fund" or portfolio.
