*QVT Fund LP (the "Fund"), with address c/o Walkers SPV, Walker House, Mary Street, George Town, Grand Cayman KY1 9001, Cayman Islands has on May 9 2007, disposed 35,996 shares in Carl Lamm AB, 556228-8851, with address Box 1536, SE-171 29 Solna (the "Transaction"). As a result of the Transaction, the Fund owned 855,865 shares, representing in total appr. 8,4% of the capital and the votes in Carl Lamm AB.*

Medräknat aktier ägda av Fonden, kontrollerade Investment Manager således rösträtten avseende totalt 1 010 499 aktier, representerande ca 9,9% av aktiekapitalet och rösttalet i Carl Lamm AB.

*QVT Financial LP, the investment manager (the "Investment Manager") for the Fund, with address at 1177 Avenue of the Americas, 9<sup>th</sup> Floor, New York, NY 10036, also, at time of the Transaction, controlled the voting of 154,634 shares in Carl Lamm AB in a different account that it manages, but as to which it disclaims beneficial ownership. Together with shares owned by the Fund, the Investment Manager exercised voting control over a total of 1,010,499 shares, representing in total appr. 9,9% of the capital of the votes in Carl Lamm AB.*
