IT – Genium INET Key Information Document Introduction – An Update

This Notice includes new information and updates to IT Notice 57/16, Derivatives – Product Information 94/16 and Clearing Information 94/16).

Introduction

The EU Regulation 1286/2014 on packaged retail and insurance-based investment products (PRIIPs), introduces key information documents (KID) for among others the Exchange Traded Derivatives. A KID gives key facts of the product to investors. Nasdaq will produce KIDs for instruments for which it will be considered to be the Manufacturer according to regulation. That will cover Nasdaq-listed derivatives (ETDs) traded on Nasdaq Derivatives Markets. The Nasdaq KIDs will initially be provided in English, Swedish, Danish, Finnish and Norwegian as well as for commodities derivatives in German. All Nasdaq KIDs for the ETDs will be available on Nasdaq FTP and webpages. The KID URLs for the English versions will be distributed via OMnet API and the Genium Consolidated Feed TIP protocol.

Updates include:

- For the KIDs on Equity, Index and Commodity Derivatives Nasdaq will produce separate documents for the Long and Short –position. This affects the Name Standard as described below.
- Nasdaq has decided not to produce any KIDs for Fixed Income Derivatives as Nasdaq's Fixed Income Derivatives are only offered to professional customers.
- Changes in the Commodities products offered.

Nasdaq issued product KIDs will be located on the following websites/FTP location at the latest in December The go-live date for the KIDs will be communicated separately via a future IT notice. However, test files will be available on the below locations for testing purposes now.

- VIB of BU123

In Genium Consolidated Feed the field "LinkProspect" in the messages BasicDataBond (BDBo) and BasicDataDerivative (BDDe) the FTP URLs for the Long and Short KID in English will be populated. The URLs will be separated by: \, i.e. a backslash and a comma.
