New Warrant Opening Sequence

OMX Nordic Exchange will implement a more efficient opening of the Warrant submarkets in Stockholm and Helsinki. They are presented below with the new submarket names, communicated in IT 11/08.

This will be carried out in two steps.

Step 1: Change of start time for opening of the submarkets (COTR) from 09:05 to 09:00.

Step 2: Change of opening order of the submarket lists and new order numbers per list as below:
