Adjustment due to extra dividend in TeliaSonera

New exercise and futures prices have been rounded off to two decimal places and received an "X" in the series designation. As a result of the adjustment the number of shares per contract has increased to 105 after rounding down to nearest full share, whereas exercise and future prices have decreased. The series have also received new ISIN-codes which are published below. The rounding off of future prices was made "trade by trade" and not on the net position.
