Share Trading in June

The value of average daily share trading amounted to SEK 33.3 billion, as compared to SEK 43.7 billion during the past 12-month period. The average number of trades per business day amounted to 189,885, as compared to 208,917 during the past 12-month period. The total market cap of listed companies at OMX Nordic Exchange amounted to SEK 6,671 billion, compared to SEK 10,096 billion in June 2007.

The average daily trading volume in derivative products amounted to 711,054 contracts, as compared to 672,186 contracts during the past 12-month period. The average daily trading volume in share products was 363,595 contracts, as compared to 332,021 contracts during the past 12 month period. The average daily trading volume in index products were 219,099 contracts, compared to 230,920 contracts during the past 12-month period. Fixed-income derivatives traded 128,361 contracts, compared to 109,245 contracts during the past 12-month period.
