OBX: Market Maker Future

From September 1<sup>st</sup> 2008, a new Market Maker agreement will be available, *MM Future*. The market maker will have to quote prices in all expiration months for the OBX Future (currently 4 months). By entering into this agreement, the market maker receives a discount of 60% per future contract; the regular price is NOK 2,50/contract, whereas a market maker with an MM Future agreement pays NOK 1,00/contract.
