## May Statistics report from the NASDAQ OMX Nordic Exchanges

### Share Trading in May

The value of average daily share trading amounted to SEK 28.2 billion, as compared to SEK 28.3 billion during the past 12-month period. The average number of trades per business day amounted to 248,664, as compared to 221,985 during the past 12-month period. The total market cap of listed companies at NASDAQ OMX Nordic Exchange amounted to SEK 5,321 billion, compared to SEK 7,507 billion in May 2008.

### Derivatives Trading

The average daily trading volume in derivative products amounted to 459,185 contracts, as compared to 594,432 contracts during the past 12-month period. The average daily trading volume in share products was 176,704 contracts, as compared to 269,824 contracts during the past 12 month period. The average daily trading volume in index products were 218,314 contracts, compared to 239,371 contracts during the past 12-month period. Fixed-income derivatives traded 64,167 contracts, compared to 85,236 contracts during the past 12-month period.

## Listings and Members

There was 1 IPO on Main Market during May and 1 IPO on First North. 1 company has been listed on First North Premier during the month. Since we launched First North Premier in February 2009 we have listed 21 companies at the segment.
