# Addendum no 2 to prospectus of 1 March 2010 for the offering of bonds issued in pursuance of section 33 e of the Danish Mortgage-Credit Loans and Mortgage-Credit Bonds etc. Act in Nykredit Realkredit A/S

In continuation of the sale of Nykredit Forsikring A/S to Gjensidige Forsikring BA, an addendum to prospectus for the offering of bonds issued in pursuance of section 33 e of the Danish Mortgage-Credit Loans and Mortgage-Credit Bonds etc. Act in Nykredit Realkredit A/S is published.

## Part III of the prospectus "Information about Nykredit" has been changed as follows:

Under item 7.1 "Organisational structure", the following text has been deleted:

"Nykredit carries on other financial business through its subsidiaries Nykredit Bank A/S (and subsidiaries), Forstædernes Bank A/S and Nykredit Forsikring A/S. Nykredit has a branch in Poland.

In 2010 Forstædernes Bank A/S and Nykredit Bank A/S will merge with Nykredit Bank A/S as the surviving company."

Instead, the following text has been inserted:

"Nykredit carries on other financial business through its subsidiary Nykredit Bank A/S (and subsidiaries). Nykredit has a branch in Poland."

Under item 13.6 "Litigation and arbitration proceedings", the following text has been added:

"In February 2010, Nykredit announced that it will increase the margin on both new and existing mortgage loans to retail customers. The competition authorities are currently considering the announced price increase."
