LEO LT, AB controlled by the Government of the Republic of Lithuania contributed to the share capital of Visagino Atominė Elektrinė, UAB with 351 316 161 ordinary share of Rytų Skirstomieji Tinklai, AB. Since the registration of new Articles of Association of Visagino Atominė Elektrinė, UAB, the Government of the Republic of Lithuania will control 79.32 % of votes at General meeting of shareholders of Visagino Atominė Elektrinė, UAB through LEO LT, AB. The rest of the votes at General meeting of shareholders of Visagino Atominė Elektrinė, UAB the Government of the Republic of Lithuania will control directly. Thus the Government of the Republic of Lithuania through the control of LEO LT, AB and Visagino Atominė Elektrinė, UAB will keep the indirect control of Rytų Skirstomieji Tinklai, AB. After the liquidation of LEO LT, AB the Government of the Republic of Lithuania will control Rytų Skirstomieji Tinklai, AB through Visagino Atominė Elektrinė, UAB.
