Since the registration of new Bylaws of Visagino atominė elektrinė, UAB, the Lithuania Government through LEO LT, AB will control 79,32% of votes at General meeting of shareholders of Visagino atominė elektrinė, UAB. The rest of the votes the Lithuania Government will control directly. The Lithuania Government through the control of LEO LT, AB and Visagino atominė elektrinė, UAB will keep the indirect control of VST, AB. After the liquidation of LEO LT, AB the Lithuania Government will control VST, AB through Visagino atominė elektrinė, UAB.
