IT – INET Production – REMINDER - Volatility Guards introduced on main equity markets in STO, HEL, CPH

As of Sept 30, NASDAQOMX will launch **volatility guards** on the main markets in Stockholm, Helsinki, and Copenhagen.

On September 27, volatility guards were successfully introduced in Iceland, the Baltics, and all First North markets. **Sept 30** is the production launch for the rest of the shares and ETFs. <u>Also see IT Notice 133/10.</u>
