Wind conditions in major parts of Europe in September 2010 were normal. In Italy, however, wind conditions were materially below normal. Furthermore, the production from the Minerva Messina and Monte Grighine projects is still affected by the final repair work performed by the wind turbine supplier.

Projects under construction

Negotiations have been entered into with respect to bridge financing of the Cagliari II project. We expect to be able to end these negotiations soon with a positive outcome.

Projects under development

In September 2010 the Company issued 900,000 shares for take-over of the Cagliari III project as well as the remaining 40% of the share capital of Energia Alternativa Srl.

Negotiations have been entered into with the minority shareholder of the four projects Brindisi, Candela, Montemilone and Guardia dei Lombardi. An agreement is expected concluded with respect to the take-over of the remaining 25% of these projects.

An Extraordinary General Meeting has been convened to be held today.
