Genium Consolidated Feed

Service window in GCF3 changed to Wednesdays from 15:00 CET

The service window for GCF3 will be changed to Wednesdays from 15:00 CET starting Wednesday April 13th, 2011. The service window will then last for the rest of the day. The markets will NOT go through the states Terminating, Post-trading and Closed that day. GCF will force orderbook summaries from source Genium INET at 15:00 CET.

AktieTorget will be removed from GENIUM Consolidated Feed Nordic Equity products as of May 1st, 2011

As previously informed, AktieTorget markets will be removed from the Nordic Equity products. The change will be in effect from May 1st, 2011. After May 1st, Aktietorget content will only be available via the separate AktieTorget product. This is a technical change in the product structure and does not affect pricing.

GCF customers that are also Aktietorget members will automatically have the Aktietorget product added to their existing GCF equity accounts. Other customers subscribing to GENIUM Consolidated Feed must actively request that the new Aktietorget product be added to an existing GCF account.

The new AktieTorget package contains both equity and fixed income markets that are operated by a third-party data provider, i.e. AktieTorget AB. The change concerns the technical products distributed via both Genium Consolidated Feed (GCF) and File Delivery System (FDS). Customers subscribing to Nordic Equity products via GCF or FDS must contact DataProducts@nasdagomx.com if they wish to keep receiving AktieTorget data.

Market Wide test for GENIUM Consolidated Feed 2.3

In coordination with the GENIUM INET for Fixed Income project a Market Wide Test (MWT) for members, vendors and ISVs will take place on the following dates:

- April 28th (18:00-20:00 CET)
- May 5th (18:00-20:00 CET)
- May 19th (18:00-20:00 CET)

For GCF the MWT will be performed in GFC3 and start at 16:30 CET. GCF3 will start up as usual in the morning, except for basic data load for GINUM INET Fixed Income and ICS sources.

Participation in the MWT is mandatory for all connected to the GENIUM INET Fixed Income platform and recommended for all connected to GCF platform, this since NASDAQ OMX wants to confirm customer readiness as well as the GENIUM INET Nordic solution prior to launch.

The Nordic Member web has been updated with new information related to the MWATs, including a template for the MWATs registration & report, test schedule for the MWATs and the MWAT plan. Please review this information to plan and prepare for the MWATs.

Please register for the MWATs no later than April 19th.
