MANAGEMENT REPORT OF JSC "OLAINES KŪDRA" ABOUT WORK DURING 6 MONTHS OF 2011

The principal activity of JSC "Olaines kūdra" in 6 months of 2011 is the following:

1. Output of milled peat
2. Production of moss peat, neutralized peat and peat substrates
3. Peat packing
4. Selling of peat production in Latvia and outside Latvia

The season of peat output in 2011 was commenced timely in May. The weather conditions in May and June were favorable for peat output; 36% of the planned amount of peat output was obtained during these two months. Frequent incessant rain in July 2011 decreased the speed of peat output. The net turnover in the 1st half-year in 2011, if comparing with the same period in the previous year, has decreased by 31.3%, but the losses after taxes have grown by 10660 LVL.

In the 6 months of 2011 JSC "Olaines kūdra" worked with losses of 28456 LVL; the amount of the losses in 6 months of the previous year was 17796 LVL; the profitability of the company was affected by the realization of the rest of peat obtained during the previous year and its high prime cost.

The company uses only its own capital for provision of its financial activity, without attraction of borrowed funds, including, bank credits.

The company has ensured timely payment of wage to the employees; the company has no tax and other payment arrears to the state and self-government budgets.

The losses per one share in 6 months of 2011 is 0,0156 LVL; the losses in 6 months of 2010 per one share constituted 0,01 LVL.
