# September Statistics report from the NASDAQ OMX Nordic Exchanges

### Share Trading

The value of average daily share trading amounted to EUR 2.4 billion, as compared to EUR 2.7 billion during the past 12-month period. The average number of trades per business day amounted to 422,834 as compared to 340,265 during the past 12-month period. The total market cap of listed companies at NASDAQ OMX Nordic Exchange amounted to EUR 602 billion, compared to EUR 748 billion in September 2010.

All figures in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK and Other in EUR). Average per trading day. All exchanges had 22 trading days.
