Netop Solutions A/S - Profit announcement for the third quarter

Decent performance in the third quarter: revenue and EBITDA in line with expectations. The initiatives approved by our Board of Directors in its review of our strategy plan were implemented during the quarter. The resulting effects will not feed through to revenue until in 2012. Management confirms the guidance for 2011.

CEO Kurt Bager said: We had a decent performance in the third quarter, as revenue and EBITDA were in line with our expectations. Revenue was not quite at last year's level, as especially the low USD/DKK exchange rate had a negative impact, but in local currency terms we're very close to last year, and that's encouraging considering the current market conditions. We have implemented the strategic initiatives approved by our Board in connection with the revised strategy announced in August. For example, we have run a number of marketing campaigns promoting Live Chat and have been getting good response. We're beginning to see growing interest for our Live Chat product in the US market. We have now primed our organization to further support the growth potential of the Live Chat product, and we expect to hire in the last of the resources we need to support our efforts in the remote control segment of the tablet and smartphone markets.

Highlights

- Revenue amounted to DKK 21.6 million in Q3 2011, compared with DKK 23.2 million in Q3 2010. The decline
 was mainly due to the lower USD/DKK exchange rate, which reduced Q3 2011 revenue by DKK 1.2 million.
 The 9M revenue was DKK 63.7 million, compared to DKK 66.2 million in the same period of 2010.
- EBITDA amounted to DKK 1.2 million in Q3 2011, against DKK 2.6 million in Q3 2010. EBITDA for the nine months to September 30, 2011 was DKK 0.5 million, against DKK 5.7 million in 9M 2010. The 2010 EBITDA profit included a one-off gain of DKK 5.0 million.
- Netop Solutions recorded a net loss of DKK 1.9 million in Q3 2011, against a DKK 3.6 million loss in Q3 2010.
 The company recorded a net loss of DKK 8.4 million for the nine months to September 30, 2011, against a DKK 4.5 million loss in 9M 2010. The 2010 net loss included a one-off gain of DKK 5.0 million.
- Management confirms the guidance for 2011 announced on August 16, 2011: we continue to expect FY 2011 revenue in the DKK 90-95 million range and FY 2011 EBITDA in the DKK 0-5 million range.

Business performance

Our management launched the initiatives approved by our Board of Directors in its review of our strategy plan. A number of marketing campaigns have been launched, mainly for our live chat product, and we have started up a process of initiating the development of products directed at the remote control segments of the tablet and smartphone markets. These activities are not expected to feed through to our revenue until in 2012.

Remote Control (formerly Administration)

Remote Control generated revenue of DKK 9.8 million in Q3 2011, a 13% fall in local currency terms and a 16% fall including exchange rate adjustments from DKK 11.5 million in the year-earlier period. Exchange rate adjustments reduced the Q3 2011 revenue by DKK 0.4 million relative to last year.

We are currently building a development team of specialists who will be focused on remote control tools for tablets and smartphones, and we are working on a number of other development initiatives intended to keep Netop Remote Control positioned as one of the leading secure remote control tools on the market.

We are generally still seeing customer uncertainty in the Enterprise market, but by stepping up our marketing efforts and other selling initiatives we have recorded an increase in the number of leads and a growing awareness of Netop Remote Control. Management believes that there will be a certain reluctance in the EMEA region during the rest of the year and into 2012, but that the US market, which is where we have made most of our marketing investments will see a slight increase in activity levels.

Classroom Management (formerly Education)

The Q3 Classroom Management revenue was DKK 10.4 million, compared to DKK 10.7 million in Q3 2011. Our sales to the US market fell by 1% in local currency terms and by 11% including exchange rate adjustments. Exchange rate adjustments reduced the Q3 2011 revenue by DKK 0.8 million relative to last year. EMEA revenue was up by 15% relative to the year-earlier period.

We launched a new version of MyVision in the Classroom Management market in the third quarter, which gained positive press reviews in our core markets. In addition, we launched back-to-school marketing campaigns and ran email campaigns through social media which reached more than 100,000 teachers across the United States. Subsequently, we have recorded an increase in traffic on our Web site, as 7000 teachers have downloaded a trial version of the product. We embarked on a number of roadshows in Germany and Switzerland, and the Netop Classroom Management products have been well received in both markets.

Live Chat (formerly Communication)

Live Chat generated revenue of DKK 0.8 million in Q3 2011, compared to DKK 1.0 million in Q3 2010. The DKK 0.2 million drop from last year was due to the fact that the revenue for 2010 was not accrued until in the fourth quarter of 2010. Based on the current forecast, we expect annual revenue growth for Live Chat of about 30%.

In the third quarter of the year, we expanded our marketing efforts in the Live Chat field. For example, we attended a two-day seminar organized by FDIH, the Danish Distance Selling and E-business Association, for businesses providing digital customer service. Netop Solutions also participated in 'Digitaliseringsmessen', a recurring Danish digitalization fair organized to support the e2012 targets of the Danish public sector for increased digital communications. The fair spotlights digital solutions and the efficiency-enhancement potential available to Danish local government. In addition, Netop Solutions, CRM Magazine and Forrester Research held an online webinar based on a Chat Report prepared by Forrester. The webinar raised a good response and produced qualified leads. We have appointed a public relations agency in the United States to promote the use of the Netop Chat solution, and a similar model has been set up in the UK.



Financial review

Revenue

Netop Solutions generated revenue of DKK 21.6 million in Q3 2011, a DKK 1.6 million or 7% fall from DKK 23.2 million in Q3 2010.

The average USD/DKK exchange rate was considerably lower in Q3 2011 than it was in Q3 2010, and exchange rate developments alone reduced revenue by DKK 1.2 million in the third quarter.

Costs

Costs of production, external costs, staff costs and impairment charges totaled DKK 23.1 million in Q3 2011, slightly down from DKK 23.6 million in Q3 2010.

External costs amounted to DKK 7.6 million in Q3 2011, compared with DKK 7.9 million in Q3 2010.

Staff costs were DKK 12.5 million in Q3 2011, compared with DKK 12.6 million in Q3 2010.

Depreciation and amortization charges were DKK 2.7 million in Q3 2011, compared with DKK 3.0 million in Q3 2010.

Financial results

EBITDA was a profit of DKK 1.2 million in Q3 2011, against DKK 2.6 million in the same period of last year.

EBIT was a loss of DKK 1.5 million in Q3 2011, compared with a loss of DKK 0.4 million in the year-earlier period.

Netop Solutions recorded a net loss of DKK 1.9 million in Q3 2011, against a loss of DKK 3.6 million in Q3 2010.



Balance sheet

At 30 September 2011, total assets amounted to DKK 99.4 million, with cash accounting for DKK 12.4 million. Equity stood at DKK 76.9 million (corresponding to an equity ratio of 77%), compared to DKK 65.8 million at September 30, 2010.

Cash flows

Operating activities generated a cash inflow of DKK 1.8 million in Q3 2011, compared with DKK 3.3 million in the year-earlier period. The Q3 2011 cash flow per share (CFPS) was an inflow of DKK 0.1, compared to DKK 0.2 in Q3 2010.

Investing activities generated a cash outflow of DKK 1.1 million in Q3 2011, compared with an outflow of DKK 1.5 million in the year-earlier period. Investing activities in the third quarter related mainly to wages and other direct costs attributable to the group's development activities.

Financing activities generated a cash flow of DKK 0.0 million in Q3 2011 compared to an outflow of DKK 10.0 million in Q3 2010. The 2010 figure reflected the settlement of a guarantee commitment in connection with the 2008 acquisition of GenevaLogic.

Accordingly, there was a total cash inflow of DKK 0.7 million in Q3 2011, compared to an outflow of DKK 8.2 million in the year-earlier period.

Outlook for 2011

In the Remote Control business (formerly Administration), Netop Solutions failed to generate the business growth anticipated, due to reluctance among clients to invest in the Enterprise market. Accordingly, a number of large orders were not closed as otherwise expected. The Enterprise business will remain a priority for Netop Solutions, and we expect revenue from this business area to be slightly lower than last year.

For the Classroom Management business (formerly Education), we maintain our targets for 2011 and expect slight revenue growth in this segment.

The Live Chat business (formerly Communication) is experiencing powerful developments and we have allocated additional sales resources to this segment in 2011. Due to the substantial growth of this market, Netop Solutions aims to position the product by stepping up marketing relative to the original plans. We expect significant revenue growth in 2011 now that Netop Live Guide is also sold through the Netop Solutions web shop.

Management confirms the guidance for 2011 announced on August 16, 2011: we continue to expect FY 2011 revenue in the DKK 90-95 million range and FY 2011 EBITDA in the DKK 0-5 million range.

The guidance for USD-denominated revenue for the rest of 2011 is based on a USD/DKK exchange rate of DKK 5.30. At a USD/DKK exchange rate of 5.40, revenue will improve by about DKK 0.5 million and EBITDA will be about DKK 0.2 million higher.
