MWAT – Market Wide Acceptance Testing

Purpose

The MWAT sessions are designed to ensure member and ISV readiness prior to the migration of all Commodities members to the Genium INET platform. The Genium INET central, front-end, back office, and surrounding systems will be tested under production like circumstances. All member/ISV applications are also tested.

Activities

- MWAT began with MWAT Log On during September, 2011
- The first MWAT was arranged on the 15th of December, 2011
- Three further MWATs are arranged on Thursday evenings January 19th, January 26th, February 9th Members are recommended to attend all sessions, as a minimum all members must participate in at least two sessions.
- ISVs are expected to support their customers, but do not need to participate, unless they are assigned by their customers
- It is expected that the members run test scenarios and cases based on their specific needs and business processes

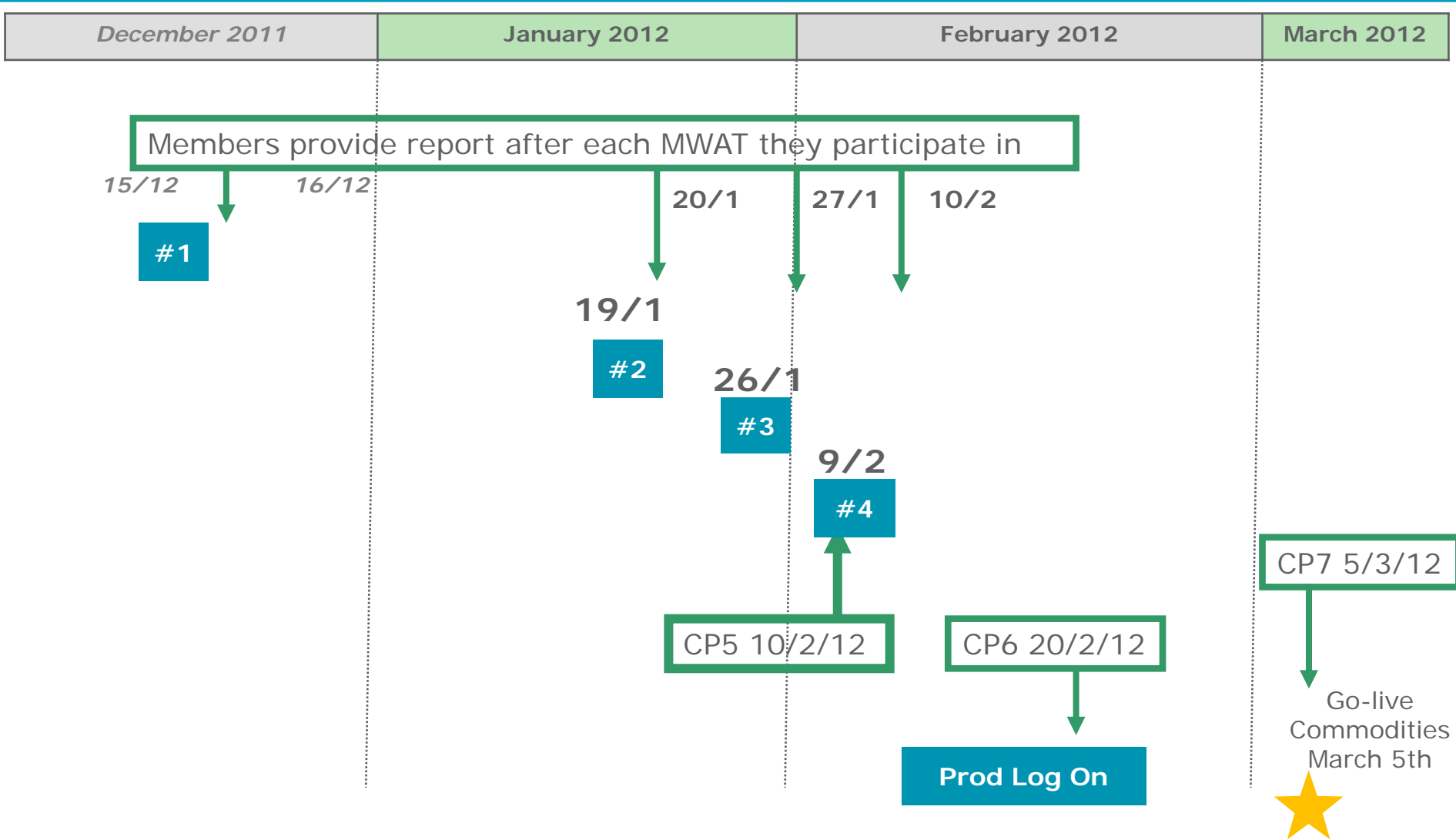

2	Test logon	3/6	ISVs and Member developed software verified logon to test environments
3a	Conformance start	22/8	Mandatory for ISV and Member with internally developed software connecting to the OMNet API or FIX: Request made for participation conformance test.
3b	Conformance end	21/10	Mandatory for ISVs and Member with internally developed software connecting to the OMNet API or FIX: Requested conformance tests finalized.
4	MWAT Log on	29/9	All members and ISVs have confirmed log on to MWAT environment.
VPN	VPN Replacement deadline	14/10	All Members on VPN connections need to have moved over to extranet VPN based connections. See separate commodities exchange information (31/2011) Members are required to have ordered and installed new VPN connectivity by the 14 October.

MWAT Participation

- In the MWAT Registration, each member has appointed a main migration contact. This person has been contacted with a direct email with a link to a webform on the member extranet asking which MWATs the member intends to take part of in
- All Commodities members need to participate in **at least two MWATs** and send a report on the following day
- All members are strongly recommended to participate in all MWATs, in particular MWAT #1
- MWATs are also open for Market data vendors and Equity Derivatives members

MWAT preparations

Please, ensure:

- Client environment and infrastructure installed and configured
- Latest versions of applications
 - Trading Workstation, Clearing Workstation 2
 - Web Trade users, ensure you can access WebTrade URL
 - Third party solutions
- Connectivity to the test environment infrastructure tested prior to MWAT
- Necessary accounts and permissions set
- Prepare own test cases for customer specific processes and tests
- Engage personnel to be active in tests including traders and backoffice personnell

- During MWAT (15 Dec onwards), members on VPN extranet solutions will exclusively use new extranet connectivity for accessing the test environment.

- Web Trade
 - Internet Based
 - Deployment using ClickOnce technology
 - Admin tools and Pre-trade limits
 - Designed to match the needs of the majority of users
- New release for Genium INET
 - No changes in interface or functionality
 - Available in external test

Important information for Trayport GW users

- Trayport Global Vision
 - New adapter application is available for download
 - Adapter must be upgraded during launch weekend
 - Reg files needs to be updated. This will be included in installation kit
 - No changes to XML config files
- Trayport Broker Services
 - No changes in interface
 - IP addresses and ports are changed

- There will be a limited amount of changes to the SPAN file due to the Genium INET migration.

MWAT functional testing

- There are no specific test case scripts; members are encouraged to create their own test cases. Below there are some general suggestions on functionalities to test, e.g. limit orders etc.
- Please use realistic prices and volumes
- Please trade the instrument series you normally would trade on
- Production ids should be used and normal trading software should be used for market making etc.

MWAT disturbance testing

- Between 15:30-15:35 some member connections will be disconnected to verify reconnections
- FIX failover test will be performed
- For GCF some member connections will be disconnected to verify reconnections

Test Report

- It is important that you use the support channels as specified towards the end of this presentation during the MWAT
- After the MWAT, all Commodities members shall complete and send in a test report to NASDAQ OMX to confirm that their applications affected by the introduction of Genium INET have been tested in accordance with industry practices
- Market data vendors and Derivatives members are also recommended to complete and send in a test report to NASDAQ OMX.
- Please use the member extranet form under Commodities for Genium INET > MWAT Feedback and send us a report by 14:00 CET on Friday after MWAT

Checkpoint 5, 10 February-2012

- All members, data centers and market data vendors have participated in minimum two MWATs and provided a report confirming readiness for launch
- Market data vendors which get the data from GCF - recommended to participate in MWATs but is optional
- Trading applications affected by the introduction of Genium INET Commodities have been tested in accordance with industry practices
