## NASDAQ OMX to disseminate Skandia Livs Sv. Fövaltningsindex 85

On February 13th, 2012 NASDAQ OMX will begin disseminating Skandia Livs Sv. Fövaltningsindex 85. The index is calculated as a market cap weighted index and designed to measure the performance of the 85 largest shares listed on the NASDAQ OMX Stockholm Exchange.

Skandia Livs Sv. Fövaltningsindex 85 has a base date of December 30th, 2011 and a base value of 100. The index values will be disseminated every 60 seconds.

The index will be added to Nordic equity and index entitlements.

# ICB - Company classification standard

## REMINDER: ICB Company classification standard to be introduced on February 1st, 2012

On February 1st, 2012 all NASDAQ OMX local and regional sector indexes included in the Nordic Equity products and VINX products, based on the GICS structure, will be discontinued, and replaced by equivalent indexes based on the ICB structure.

#### Conflicting short name codes/symbols

There are six (6) indexes that have a conflicting index codes/symbols between the current GICS indexes and the new ICB indexes. A temporary code/symbol will be used during the period of parallel productio between January 9th and February 1st, 2012. It means that a temporary "X" is included in the index code in the production environment for the below indexes. When launched on February 1st, 2012, the "X" will no longer be in the index code.
