During March, 373,131 new B shares were issued in Elekta through the exercise of warrants distributed within the framework of the established option program.

The total number of shares in Elekta as of March 30, 2012 amounts to 95,226,675 divided between 3,562,500 A shares and 91,644,175 B shares.

One A share entitles the holder to ten votes and one B share to one vote.
