Net Asset Value in East Capital Explorer per 30 April 2009

- On 30 April 2009 the net asset value per share in East Capital Explorer amounted to EUR 7.62 (corresponding to SEK 81.23 i). The total net asset value amounted to EUR 270.5m (corresponding to SEK 2,883.5m)
- The change in the total net asset value (EUR) was +4.3 percent compared to 31 March 2009. On 30 April 2009 the total number of shares outstanding in East Capital Explorer amounted to 35,499,160, which, due to the repurchase of own shares during the month, was 286,000 shares less than the number of shares outstanding on 31 March 2009
- Cash and deposits per share amounted to EUR 4.91 (SEK 52.34), corresponding to a
 total of EUR 174.4m (SEK 1,859.1 m) of which EUR 100.3 m (SEK 1,069.2 m) is
 available for future investments
- The closing price per share on 30 April 2009 was SEK 53.50 (corresponding to EUR 5.02)
