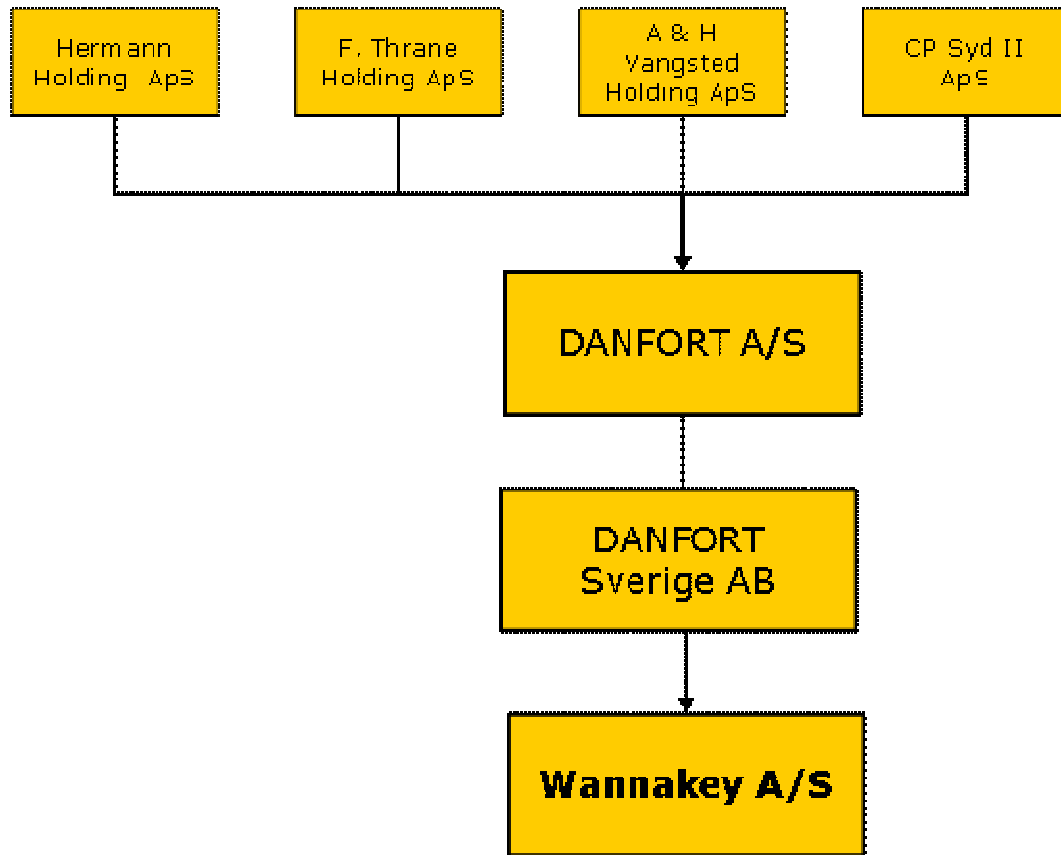
### Major stockholder notification

As at today's date, Wannakey A/S has received notification from A&H Vangsted Holding ApS that this company has increased its stockholding in Danfort A/S to 48%.

The direct and indirect stockholding of the Supervisory Board and the Executive Committee in the company is thus:

DANFORT Sverige AB: 3.025.000 stocks, corresponding to approx. 91.9 % of the capital stock. This company is 100% owned by DANFORT A/S, which is indirectly owned by Supervisory Board members, Arne Vangsted (48%), Per Conradsen (16%), Kim Andersen (18%) and Flemming Thrane (18%). A&H Vangsted Holding ApS: 242,703 stocks, corresponding to approx. 7.4 % of the capital stock. This company is owned by the Board member, Arne Vangsted.

The applicable shareowner agreement regarding Danfort A/S will not be changed and each stockholder in Danfort A/S has thus the continued right to appoint 1 member of the Board.
