In connection with the publication of the tender offer to the shareholders of Forstædernes Bank A/S, this addendum to Prospectus for bonds issued in pursuance of section 33 e of the Danish Mortgage-Credit Loans and Mortgage-Credit Bonds etc. Act (Junior Covered Bonds) in Nykredit Realkredit A/S is published. The tender offer has been published by stock exchange announcement dated 15 September 2008 to which reference is made.

Part III "Information about Nykredit" of the prospectus has been changed as follows:

A new item 5.2 Investments is inserted with the following text:

"On 15 September 2008, Nykredit submitted a tender offer to the shareholders of Forstædernes Bank A/S. The tender offer was made on 15 September 2008 and expires on 13 October 2008 at 20:00. The tender offer is subject to Nykredit obtaining acceptance by shareholders representing more than 90% of the share capital. The shareholders of Forstædernes Bank A/S have been offered a cash consideration of DKK 105 for each share of DKK 25 nominal value, which corresponds to a total value of the outstanding shares in Forstædernes Bank A/S of DKK 1,823m.

For more details about the tender offer, please refer to the stock exchange announcement dated 15 September 2008 and Offer Document - Recommended tender offer to the shareholders of Forstædernes Bank A/S, also dated 15 September 2008. The contemplated acquisition will be financed by available funds and amounts drawn on Nykredit's existing credit facilities."
