### Sjælsø Gruppen A/S – programme for the repurchase of shares

As stated in the company's announcement regarding the annual accounts released on 4 March 2008, Sjælsø Gruppen A/S has initiated a programme for the repurchase of shares.

According to the programme for the repurchase of shares, Sjælsø Gruppen A/S will buy own shares in the amount of up to 200 million DKK in the period 5 March 2008 until 31 December 2008.

The programme will be made according to the "Safe Harbour" provisions in EU decree No. 2273/2003 of 22 December 2003 (however, with the modification that the purchased shares will not be cancelled). Consequently, Sjælsø Gruppen A/S will announce the accumulated purchases under the programme every 7<sup>th</sup> day of trading.

Consequently, the total repurchase of shares of Sjælsø Gruppen A/S in the period 5 March 2008 until 16 September 2008 will be 1,195,813 shares at a total acquisition cost of DKK 127.5 million.

The above trade entails that Sjælsø Gruppen A/S owns a total of 1,195,813, shares of nominal 10 DKK equaling 4.59 per cent of the total number of issued shares which is 26,063,274.

The latest announcement was as of 8 September 2008 with the information that Sjælsø Gruppen A/S owned 4.39 per cent of the company's share capital.

Sjælsø Gruppen A/S has as previously stated reserved 675,000 shares from its own portfolio in connection with the final settlement of the purchase sum for the IBI Group. The shares will be transferred to the IBI Group's previous owners on September 30, 2008
