TrygVesta A/S – Weekly report on share buy backs

On 4 April 2008 TrygVesta initiated a share buy back programme in compliance with the EU Commission Regulation no. 2273/2003 of 22 December 2003, the so-called Safe Harbour Regulative for share buy back.

Under the programme TrygVesta will purchase own shares for an amount of DKK 1,405m in the period from 4 April 2008 to the day prior to the release of the full year results 2008, which is planned to be released 3 March 2009.

Since the announcement of 14 July 2008, the following transactions have been made under the share buy back programme:

Since the share buy back programme was initiated on 4 April 2008, the total number of repurchased shares is 1,466,750 for a total amount of DKK 551m.

With the transactions stated above, TrygVesta owns a total of 2,167,242 own shares, corresponding to 3.2% of the share capital. The total amount of shares in TrygVesta is 68m including own shares.
