Electrolux issues bond loan

Electrolux today issued a SEK 1,000m bond loan under its EMTN (Euro Medium Term Note) program.

The bond loan is issued on March 26, 2013, with a maturity on March 26, 2018. A part of the loan, SEK 400m, is issued at fixed rate and carries a coupon of 2.875% annually. The remaining part, SEK 600m, has a floating interest rate.

The bond will be listed on the Luxembourg Stock Exchange. The proceeds of the offering will be used for general corporate purposes.
