FormueEvolution I A/S – preliminary announcement regarding admission to trading and official listing with issuance of new shares

In connection with the admission to trading and official listing of FormueEvolution I, a minimum of 10,000 new shares of DKK 10,000 and maximum 100,000 new shares of DKK 10,000 are offered.

The subscription price has been fixed at DKK 10,150 per share of DKK 10,000, and the subscription period will run from March 31 till April 17 at 16.00, both days inclusive. The offering may not be closed earlier than 31 March 2008 at 16.00 CET.

The new shares are expected registered with the Danish Commerce and Companies Agency on 24 April 2008.
