# Restatement of historical figures following the divestment of TDC Finland

June 2014



#### **Financial data**

June 4, 2014 TDC announced that the divestment of its Finnish subsidiaries TDC Oy Finland and TDC Hosting Oy to DNA Oy has been completed. Comparative figures in the income statements and cash flow statements have now been restated, and this is an extended version of page 28 in the conference call slide deck from May 6, 2014. The restated figures and changes in 2012, 2013 and Q1 2014 can be seen from page 3.

The financial results of Finland are effective from the Interim Financial Report for January-June 2014 classified as "discontinued operations". Furthermore, there are revenue and cost effects in Business, Wholesale, cost centres and remaining Nordic activities (Norway and Sweden) due to the divestment of Finland<sup>1</sup>.

#### **Operational data**

The divestment of Finland have also changed the operational data in Nordic, along with the number of employees and TDC recommendation score.
