<b>Capital centre</b>	The bonds are issued from BRFkredit's Capital Centre E  Collateral for the bonds consists of that part of BRFkredit's assets, which is placed in Capital Centre E, including mortgages on real property, other forms of security and the personal liability of the borrowers. Further collateral stems from the remaining assets of BRFkredit under S.31 of the Danish Mortgage Credit Loans and Mortgage Credit Bonds etc. Act.  Please note that item 4.8.6. in the base prospectus applies.
<b>Denomination</b>	0.01
<b>Currency</b>	DKK (Danish kroner)
<b>Callability</b>	The bonds are non-callable on the part of both BRFkredit and the creditor.
