FIX DROP

The Fields and enum values added to the FIX Order Entry Execution Report are also relayed over the FIX Drop.

FIX OUCH DROP

The Fields and enum values added to the FIX Order Entry Execution Report are also relayed over the FIX OUCH Drop.

OUCH

Three new fields are added to the end of the Enter Order (section 3.1) and Order Accepted (section 2.2.1) messages:
