

Grant of Warrants to Genmab Employees

Company Announcement

Copenhagen, Denmark; October 15, 2014 – Genmab A/S (OMX: GEN) announced today that at a board meeting the board decided to issue 57,750 warrants to employees of the company as well as the company's subsidiaries.

The exercise price for each warrant is DKK 220.40. Each warrant entitles the owner to subscribe one share of nominally DKK 1. On the basis of an exercise price of DKK 220.40 and by application of the Black-Scholes formula, the average value of each warrant can be calculated as DKK 83.91 based on an interest rate of 0.2760% and the historical volatility of Genmab A/S shares calculated at 47.27%.

The warrants vest in blocks of 25% one, two, three and four years after the grant date, and all warrants expire at the seventh anniversary of the grant date. The new warrants were granted pursuant to the warrant plan adopted by the board on April 25, 2012.
