### RTX A/S initiates a new share repurchase programme

The Supervisory Board in RTX A/S (RTX) has decided to exercise the authority to repurchase shares granted by the Annual General Meeting on 31 January 2014. The authority is valid until RTX's Annual General Meeting in January 2015 and covers a maximum value of up to DKK 12 million, of which DKK 10 million have been exercised in the period from 3 February 2014 to 20 November 2014. RTX expects to exercise the full authorization given to repurchase shares for the maximum permitted value of DKK 12 million in the period until the next Annual General Meeting in January 2015.

As of 26 November 2014, RTX holds 353,977 treasury shares of a nominal value of DKK 5, equal to 3.99% of outstanding shares.

The share repurchase programme runs from 26 November 2014 to 22 January 2015. In this period RTX will acquire shares with a value of up to DKK 2 million. The share repurchase programme is initiated and structured in compliance with the EU Commission Regulation No. 2273/2003 of 22 December 2003 (the so-called Safe Harbour Regulative for share buy-back programmes) which ensures that RTX is protected against violation of insider legislation in relation to the share buy-back programme.

### Conditions for the share repurchase programme

The purpose of the share repurchase programme is to address the company's capital structure and to hedge sharebased payments.

RTX has entered into a contract with ABG Sundal Collier, in which ABG Sundal Collier acts as financial advisor and as Lead Manager of the programme. ABG Sundal Collier handles all purchase transactions independently and without influence from RTX.

The maximum amount that RTX may pay for shares purchased under the share repurchase programme is DKK 2 million. The authorization of the Annual General Meeting gives RTX authority to own up to 10% of own shares.

The shares cannot be purchased at prices exceeding the higher of (i) the price of the latest independent trade and (ii) the price of the highest independent bid on NASDAQ OMX Copenhagen at the time of the transaction.

Due to low liquidity in the company shares, and in accordance with the Safe Harbour Regulative, the Board has decided to deviate from the limit of purchase of no more than 25% of the average daily volume of the company shares traded on NASDAQ OMX Copenhagen during the previous 20 trading days. Thus, the maximum of shares bought every trading day is equivalent to 50% of the average daily volume of company shares traded in the previous 20 trading days.

RTX A/S will announce the number of purchased shares, as well as the value, on a weekly basis in a separate announcement to NASDAQ OMX Copenhagen.
