Changes to the Supervisory Board of Carlsberg A/S

The Carlsberg Group announces that at its AGM on 26 March 2015, Lars Rebien Sørensen, Chief Executive Officer of Novo Nordisk, will be proposed to join the Board to replace Jess Søderberg, currently Deputy Chairman, who will stand down from the Board at the end of the election period, having reached the age of 70.

Commenting on the change of directors, Chairman of the Board Flemming Besenbacher says: "I'm delighted that the Board is proposing Lars Rebien Sørensen as a new member. Lars is a businessman of great standing and calibre. He has significant international business experience in general management and marketing, and is an experienced non-executive director, all of which will be of great value to Carlsberg.
