Indutrade acquires Relekta Group in Norway

Indutrade has signed an agreement to acquire all of the shares in the Relekta Group (Relekta AS, Norsk Industrielje AS and Relekta Service AS) in Oslo, with annual sales of NOK 250 million.

Relekta is a Norwegian technology sales company that supplies products for construction, repair and maintenance primarily for the construction industry, automotive workshops and general industry in Norway. The company has a nationwide sales organisation and broad customer base.

“The acquisition of Relekta strengthens our position in the construction, repair and maintenance market,” says Johnny Alvarsson, President and CEO of Indutrade.

Rune Arnhoff, CEO of Relekta comments: “Indutrade was the natural choice for Relekta on account of their long-term approach and business philosophy, which is based on further developing existing, successful businesses. We look forward to expanding further and in growing our market shares in Norway as well as in other Nordic countries together with Indutrade and their network.”

Possession takes place with immediate effect, and the company will be part of Indutrade's Industrial Components business area. The acquisition is expected to have a marginally positive impact on Indutrade's earnings per share.
