COOP NORGE HANDEL AS SELECTS PRICER SOLUTIONS FOR 150 STORES

Pricer announces that Norsk Butikkdrift AS, a fully owned subsidiary of COOP Norge Handel AS and PSI Systems AS, a fully owned subsidiary of PSI Group ASA, have signed an agreement regarding deliveries, installation and services of Pricer's Electronic Shelf Labels for 150 former ICA stores that COOP will convert to COOP Extra stores.

The agreement is valued at approximately MSEK 110. The infrastructure and solutions will be delivered and installed during 2015 and 2016, starting in June 2015.

Pricer's platform, based on high speed infrared technology, enables the replacement of the store's paper price labels with electronic shelf labels. These small wireless electronic devices, the same size as paper labels, graphically display the product and price information and automatically receive price updates and relevant stock information from the retailer's distributed databases, as well as being able to connect through NFC capability to the retailer's web platform for a seamless omnichannel experience.

"We are proud to have been chosen to equip COOP Norge Handels' 150 stores. This reinforces our excellent cooperation with PSI and their trust in Pricer's digital shelf-edge solutions", concludes Jonas Vestin, CEO at Pricer.
