## **June Statistics report from the Nasdaq Nordic Exchanges**

#### **Share Trading**

The value of average daily share trading amounted to EUR 2.9 billion, compared to EUR 2.9 billion during the past 12-month period. The average number of trades per trading day was 403,390 compared to 388,770 during the past 12-month period. The total market cap of listed companies at Nasdaq Nordic Exchange amounted to EUR 1 121 billion, compared to EUR 982 billion in June 2014.

All figures in local currency (Stockholm in SEK, Helsinki in EUR, Copenhagen in DKK and Other in EUR). Average per trading day. Riga had 19 trading days, Tallinn had 20 trading days and all other exchanges had 21 trading days.
