Nemus Holding AB with its registered office in Göteborg, Sweden, (hereinafter referred to as "Nemus Holding") acting individually as well as on behalf of Mr. Thomas Onstad, a supervisory board member of Arctic Paper S.A. with its registered office in Poznan (hereinafter referred to as "Arctic Paper") and on behalf of Håfreströms Företagspark AB with its registered office in Mellerud, Sweden, (hereinafter referred to as "HÅFAB") hereby notifies of the change of shares in Arctic Paper held by Swedish companies controlled by Mr. Thomas Onstad – HÅFAB and HÅFAB's parent entity Nemus Holding. On July 8<sup>th</sup>, 2015 Nemus Holding transferred to HÅFAB 1,350,000 shares in Arctic Paper, which constitutes 1.95% of Arctic Paper's shares.

We would also like to inform you that:

- Before settlement of the transaction referred to above, Mr. Thomas Onstad held (directly as well as indirectly, through Nemus Holding) 47,205,107 shares in Arctic Paper, constituting 68.13% of the share capital of Arctic Paper and representing 47,205,107 votes constituting 68.13% of the total number of votes at the General Meeting of Arctic Paper;
- 2) Before settlement of the transaction referred to above, Nemus Holding held directly 41,356,449 shares in Arctic Paper, constituting 59.69% of the share capital of Arctic Paper and representing 41,356,449 votes constituting 59.69% of the total number of votes at the General Meeting of Arctic Paper;
- 3) Before settlement of the transaction referred to above, HÅFAB held directly 0 shares in Arctic Paper, constituting 0% of the share capital of Arctic Paper and representing 0 votes constituting 0% of the total number of votes at the General Meeting of Arctic Paper;
