



Ambu A/S – Capital Increase in connection with exercise of warrants issued

In April 2011, Ambu issued 440,000 warrants and in April 2012 507,600 warrants, each warrant entitling the holder to subscribe for one Class B share with a nominal value of DKK 2.50. 49 employees participate in the 2011 scheme, and 69 employees participate in the 2012 scheme. In both cases, the vesting period is three years, and both schemes can therefore be utilised in the trading window that opened on 19 August 2015 in connection with Ambu's interim report for Q3 2014/15.

Since 19 August 2015, instructions have been received to exercise warrants as follows:

- 2011 scheme: Two employees have issued instructions to exercise a total of 4,000 warrants at the agreed exercise price of DKK 40.125 and
- 2012 scheme: Six employees have issued instructions to exercise a total of 12,000 warrants under the 2012 scheme at the agreed exercise price of DKK 39.50.

Today Ambu's Board of Directors decided to carry out the capital increase relating to the exercised warrants.

As a result of the capital increase, Ambu's share capital will be increased by a nominal amount of DKK 40,000 from DKK 120,614,800 to DKK 120,654,800 through the issue of 16,000 Class B shares. The share capital is now divided into 41,397,920 Class B shares of DKK 2.50 each and 6,864,000 Class A shares of DKK 2.50 each.

Following this and in consideration of the employees having left the company, a total of 28,000 remaining warrants under the 2011 scheme are now being held by two individuals, while 134,000 remaining warrants under the 2012 scheme are now being held by 12 individuals.

The new Class B shares are expected to be admitted to trading and public listing on NASDAQ OMX Copenhagen A/S on 31 August 2015 under the ISIN code for Ambu A/S's existing Class B shares (DK0060591204).
