Addendum to prospectus for the offering of mortgage bonds in Totalkredit A/S

In connection with the publication of Totalkredit's Q1-Q3 Interim Report 2007, this addendum to the prospectus for the offering of mortgage bonds in Totalkredit A/S dated 28 June 2005 is published.

Section II "Risk factors" of the prospectus has been changed as follows:

In item 6 "Balance principle", the existing text under item "1. The statutory requirement for placing the proceeds..." has been replaced by: "1. The statutory requirement for placing the proceeds in eligible assets in connection with the issuance by mortgage banks of mortgage bonds, SDROs or SDOs, other securities issued by mortgage banks conferring a preferential right on the holder."

Section III "Information about Totalkredit" of the prospectus has been changed as follows:

Under item 3.2 "Selected financial information", reference is also made to the Q1-Q3 Interim Report 2007.

Under item 5.2.1 "Information about Totalkredit", reference is also made to the Q1-Q3 Interim Report 2007

Under item 13.5.2 "Information about the issuer's assets, liabilities, equity, financial position and results", reference is also made to the Q1-Q3 Interim Report 2007.

Under item 13.7 "Significant changes in the issuer's financial and trading position", reference is also made to the Q1-Q3 Interim Report 2007.

Section IV "Bond information" of the prospectus has been changed as follows:

Under item 7 "Further information", a new item 7.6 has been added: "All open ISINs in Capital Centre C will be closed at end-2007 to ensure that bonds issued in these ISINs can maintain their status as SDOs (covered bonds)"

Furthermore, the list of documents referred to has been changed as a new item "Stock exchange announcement dated 08.11.07" has been added.
