Royal Bank of Canada has agreed to issue EUR100,000,000 of 1.625 per cent. Covered Bonds due 14 January 2036, Series CB28 (the "Covered Bonds") pursuant to the €32,000,000,000 Global Covered Bond Programme of Royal Bank of Canada, unconditionally and irrevocably guaranteed as to payments by RBC Covered Bond Guarantor Limited Partnership (the "Programme").
