Royal Bank of Canada has agreed to issue EUR112,000,000 1.616 per cent. Covered Bonds due 15 December 2034 (to be consolidated and form a single Series CB27 with the EUR298,500,000 1.616 per cent. Covered Bonds due 15 December 2034 issued on 15 December 2015) (the "Covered Bonds") pursuant to the €32,000,000,000 Global Covered Bond Programme of Royal Bank of Canada, unconditionally and irrevocably guaranteed as to payments by RBC Covered Bond Guarantor Limited Partnership (the "Programme").
