### LUCARA DIAMOND NAMING CONTEST

**February 3, 2016 (LUC – TSX, LUC – BSE, LUC – Nasdaq Stockholm) Lucara Diamond Corp.** (“Lucara” or the “Company”) is pleased to announce that a contest is underway for the official naming of the extraordinary 1,100+ carat Type IIa diamond recovered in November of last year from the Company’s Karowe mine in Botswana.
