The following amendments have been made to the form of Final Terms attached to the Publication of Prospectus announcement released on 16 March 2016 at 15:20 under RNS No 3362S:

ISIN Number "XS1381479085" was replaced with ISIN Number "XS1381295945" in the Final Terms; and

Common Code "138147908" was replaced with Common Code "138129594" in the Final Terms.

All other details remain unchanged.

Royal Bank of Canada has agreed to issue CNY 150,000,000 5.00 per cent. Notes due March 2019, Series 25549 (the "**Notes**") pursuant to its Programme for the Issuance of Securities (the "**Programme**").
