### Risto Siilasmaa

Currently Chairman of the Board

Risto Siilasmaa is the founder of F-Secure and served as the President and CEO of the company until November 5, 2006. Since then he has held the position of Chairman of the Board of Directors. Risto Siilasmaa joined the Board of Directors of Nokia Corporation in 2008 and became Chairman of the Board in May, 2012. In addition he served as an interim

CEO of the company during 09/2013 – 04/2014. He is Chairman of the Board of The Federation of Finnish Technology Industries as well as a board member of the Confederation of Finnish Industries (EK). He is also a member of the European Roundtable of Industrialists (ERT) and the Tsinghua SEM Advisory Board at Tsinghua University.

Mr Siilasmaa has received several awards including Nordic Chairman of the year 2009, the Most Influential IT Leader 2007 and The Leader of the Decade 2003.
