OUTOKUMPU – ANNOUNCEMENT REGARDING CHANGE IN HOLDINGS

Outokumpu Oyj (business identity code: 0215254-2) has on April 21, 2016 received a notification based on Chapter 9, Section 5 of the Finnish Securities Market Act. Invesco Limited's total holding in the shares and voting rights of Outokumpu Oyj exceeded 5% threshold and was 5.01% (20,866,776 shares and votes) on April 20, 2016. Invesco Limited's earlier total holding in Outokumpu was less than 5.00%.

Invesco Limited's indirect holding through controlled undertakings was on April 20, 2016 above minimum threshold shares and voting rights of Outokumpu Oyj (20,866,776 shares and votes).
