Ryhov County Hospital in Sweden acquires four C-RAD Systems

C-RAD has secured an order for three Catalyst HDTM systems and one Sentinel 4DCTTM system from Ryhov County Hospital in Jönköping, Sweden. The order has a total value of 5.2 MSEK.

The Catalyst HDTM will be delivered with the complete software configuration containing modules for Respiratory Gating, Patient Setup and Positioning, and Motion Monitoring, as well as interfaces to the CT and the Varian TrueBeam® linear accelerator. The customer also selected C-RAD's unique audio-visual couching functionality, which supports an interactive gating mode. Delivery and installation of the order is scheduled for August, 2016.

The Catalyst HDTM and SentinelTM systems enable the high-end treatment techniques within radiation therapy that are increasingly common. With this dual solution C-RAD supports the whole 4D treatment chain from imaging to treatment delivery. Respiratory gated treatments are frequently used when the target volume is close to cardiac tissue, or for special treatments in which the tumor position depends on the respiratory cycle.

"Catalyst HD was developed specifically for the fast-growing segment of Stereotactic Radiation Therapy (SBRT) and Stereotactic Radiosurgery (SRS), but at the same time Catalyst HD provides the proven advantages of the Catalyst system for treating breast cancer patients, as well as patients with other indications. In this way, the clinic can utilize the full range of advantages of surface tracking technology."

C-RAD has established three companies for direct sales: C-RAD Inc. in the US, C-RAD GmbH in Germany and C-RAD WOFE in China. Cyrpa International SPRL, a Franco-Belgian laser company, is a wholly owned subsidiary whose operations are being integrated. C-RAD AB is listed on NASDAQ Stockholm.
