WEEKLY SHARE REPURCHASE PROGRAM TRANSACTION DETAILS

October 24, 2016

SBM Offshore reports the transaction details related to the repurchase of its common shares made for the period October 17, 2016 through October 21, 2016.

The repurchases were made under the EUR 150 million share repurchase program for share capital reduction purposes and, to a lesser extent, for employee share programs. Full time company employees (4,900) are spread over five regional centers, eleven operational shore bases and the offshore fleet of vessels.
