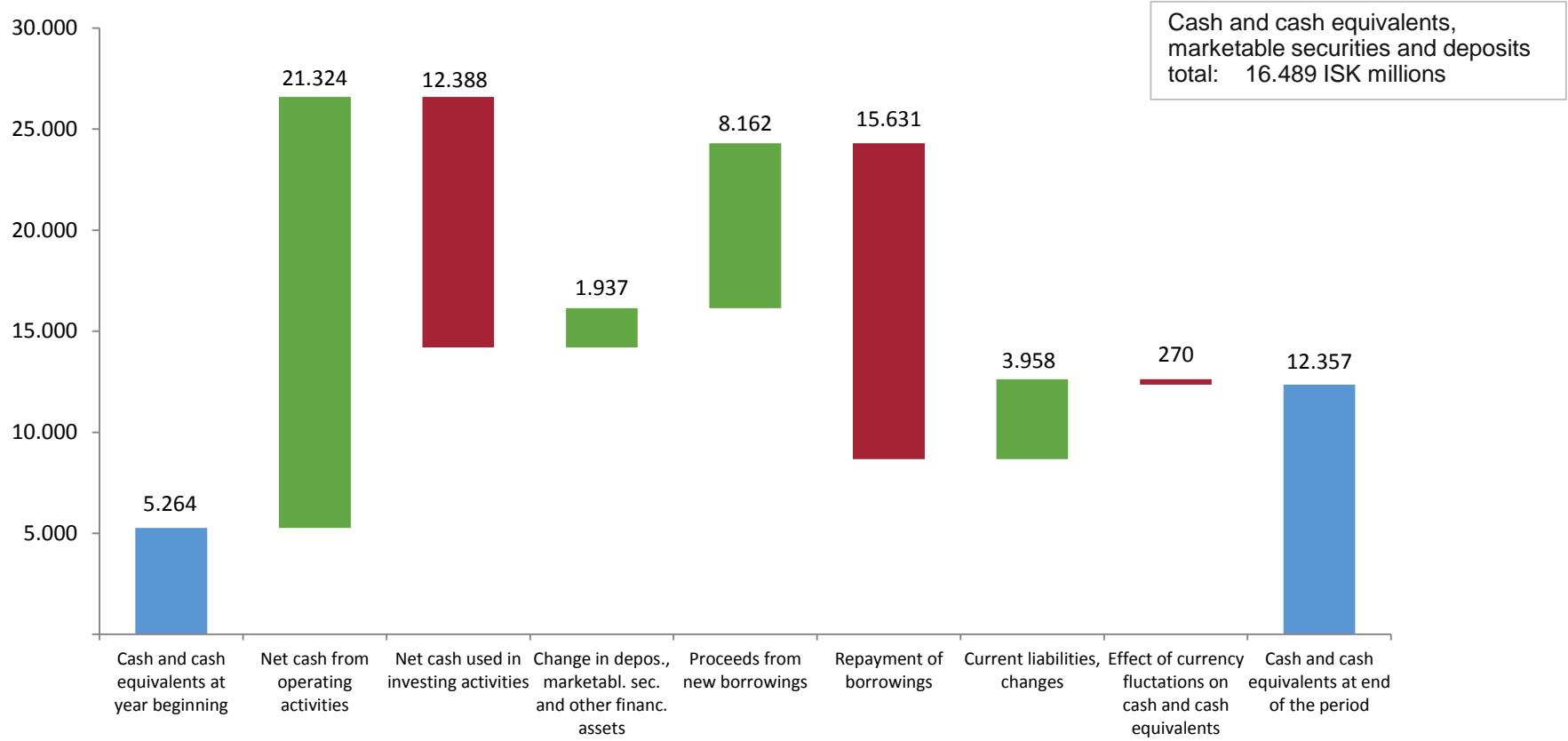

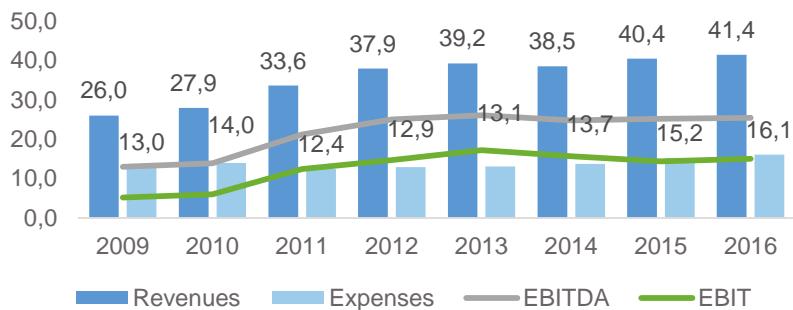

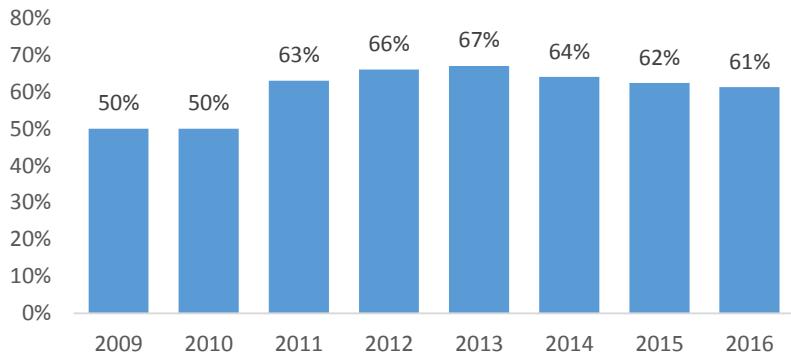

Revenues, expenses, EBITDA and EBIT



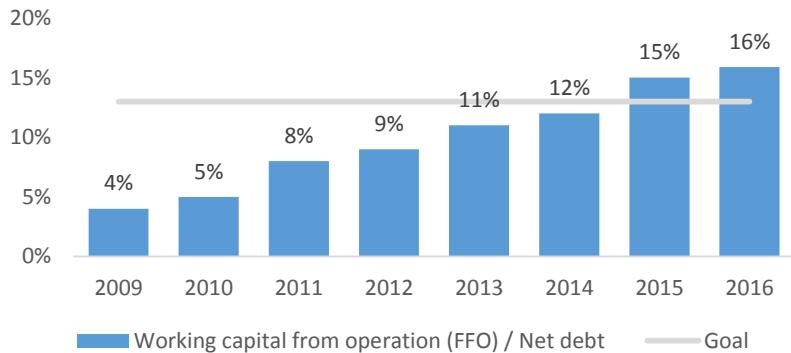
EBITDA margin
