

NEW SETTLEMENT PRODUCTS FOR NORDIC FIXED INCOME INSTRUMENTS

With the next Genium Inet upgrade on May 8th Nasdaq Clearing will introduce new settlement products for Nordic Fixed Income Derivatives contracts, hence replacing some of the existing ones. Settlement products are used to group Instrument Types to bookkeeping accounts in Genium Inet. Please note that the actual effective date of the proposed changes will be June 1st even though they are technically part of the May release.

The table below outlines the changes that will be effective from June 1st:
